2. OVERVIEW OF THE IMPLEMENTATION OF THE COOPERATION PROGRAMME (ARTICLE 50(2) OF REGULATION (EU) NO 1303/2013 AND ARTICLE 14(3)(A) OF REGULATION (EU) NO 1299/2013)

Key information on the implementation of the cooperation programme for the year concerned, including on financial instruments, with relation to the financial and indicator data.

The programming of the CP Interreg V-B "Balkan-Mediterranean 2014-2020" (BalkanMed) started upon approval by the European Commission competent services in December 2013 of the explicit request put forward by the participating countries (Albania, Bulgaria, Cyprus, The former Yugoslav Republic of Macedonia and Greece) to set up a third transnational Cooperation Programme, aiming to cover cooperation inconsistencies following the initial split of the South East Europe 2007 – 2014 into two macro-regional cooperation areas, the Danube and Adriatic – Ionian. The actual drafting of the BalkanMed Programme started in 2014, with the establishment of a dedicated Task Force in February 2014, with the duty to coordinate the preparation of the new Programme. The Task Force was composed of officials from all five participating countries.

An expert was contracted to draft the new Programme. Another expert was contracted to draft the Strategic Environmental Assessment and the Ex-ante Evaluation of the Programme.

Particular emphasis was given in generating the interest and input of the Programme stakeholders and civil society for the new Programme. To this end, national and local authorities, past project partners participating in the "South East Europe" Programme, potential beneficiaries and other stakeholders were invited to submit their comments on the Programme's strategy and goals. The first draft of the Programme and the citizen's summary was available for public consultation by the public. In addition, eight (8) relevant events were organized in the cooperation area.

The Managing Authority coordinated the above procedures and took care that the new Programme embedded the needs of the stakeholders and the recommendations of the Ex-ante Evaluation. The first draft of the BalkanMed Programme was officially submitted to the European Commission in September 2014.

The Commission examined the programming document and made observations, which were fully integrated. The Programme was revised accordingly by the Managing Authority and the Task Force and was re-submitted to the European Commission in May 2015. The CP was adopted on 25/09/2015.

Following the adoption of the Programme, the 1st meeting of the BalkanMed Monitoring Committee took place on 25-26 November 2015 in Corfu, Greece. At the meeting, several key BalkanMed documents were approved:

- Rules of Procedure of the Monitoring Committee;
- Technical Assistance Annual Breakdown and Technical Assistance Manual;
- Communication Strategy;
- Programme Manual;
- Project Implementation Manual;
- 1st Call for Project Proposals and all its supporting documents;

• Joint Secretariat profiles and recruitment procedure.

The 1st Call for Project Proposals was officially launched on 16/12/2015 with the note that it would be open until 15/04/2016. The deadline for submission of Project Proposals was extended to 26/04/2016, following a unanimous decision of the Monitoring Committee. Eligible partnerships should include partners from at least three participating countries. The Call had a budget of € 20.1 mil. (85% of which is covered by EU funds) and was open to both Priorities.

Regarding e-cohesion, the Managing Authority of European Territorial Cooperation Programmes in Greece, as Managing Authority –among others- of the Interreg V-B "Balkan-Mediterranean 2014-2020" Programme, is in constant and close cooperation with the Special Service of MIS in order to finalize the electronic system that is going to fulfill the requirements concerning "E-Cohesion" in relation to European Territorial Cooperation Programmes.

The Hellenic MIS has been developed to support (initially) the mainstream Operational Programmes 2014-2020, ensuring full electronic management of data and procedures on both Programme and project level. More specifically, the MIS covers the specific requirements as set out in EU 1011/2014 (Article 9, §1 & Article 10 §1 & §4) and EU 821/2014 (Article 8 §1) focusing particularly:

- on the electronic exchange of information between beneficiaries and management and control bodies (i.e. enabling reduction of administrative burden for beneficiaries),
- on the facilitation of interoperability between National and Union legal frameworks, while allowing beneficiaries to submit only once all information related to the electronic data exchange (i.e. enabling electronic data exchange on programme implementation level).

The MIS is currently undergoing some necessary adaption to ensure coverage of the specific features of Interreg Programmes for the Programming Period 2014-2020, including electronic submission of Project proposals. Project level requirements shall be adequately operational within the year 2016.

As the actual implementation of the BalkanMed Cooperation Programme started only in late December 2015, no activities were carried out and no expenditure was incurred in the years 2014 and 2015.
